KS-19206 BOOTH

IDENTIFICATION AND ASSEMBLY OF PARTS

1. GENERAL

- 1.01 This section is reissued to:
 - Reflect minor changes in design
 - Revise illustrations
- 1.02 Since this reissue covers a general revision, arrows ordinarily used to indicate changes have been omitted.




Fig. 1 - KS-19206 Booth

- 1.03 The KS-19206 booth (Fig. 1) is designed for indoor use only. The exterior is gray vinyl painted steel. The interior is composed of off-white porcelain enamel liners.
- 1.04 The booth may be installed in single or multiple units. See Table A for list numbers available.
- 1.05 A contour seat is provided in the left rear corner for sit-down service. Also featured is a writing shelf which extends along the right side and part of the rear wall. Both are furnished as part of the booth.
- 1.06 A KS-19268, List 1 rubber mat covers the floor.
- 1.07 The booth has a single curved door that rolls into a recess on the left side behind the seat. The door is equipped with two glass panels separated by a horizontal center rail.
- 1.08 The booth is designed to mount a variety of coin telephone sets by using the appropriate installation kits. See Table A.




Fig. 2 — KS-19207, List 1 Light and Blower Unit

- 1.09 A KS-19207, List 1 light and blower unit (Fig. 2) is provided in the booth. This unit contains one circular 40-watt fluorescent lamp and a blower that is mounted in the center. Both the light and blower may be controlled by

a door-operated switch assembly (B-650626). The blower may also be controlled by a wall-mounted switch assembly (B-555994) and the lamp may be wired for continuous illumination. The installation section shows the various wiring options.

1.10 A sign, illuminated by a 20-watt fluorescent lamp (G. E. F30-T8-CW-4, Westinghouse F18-T8-CW-30, or Sylvania F18-T8-CW-K-30), is mounted above the door. Available signs are listed in Table A.




Fig. 3 — KS-19206 Booth Ceiling Assembly

- by means of a KS-16797, List 15 cable assembly (Fig. 3). The cable is furnished as part of the booth assembly for plugging into the power-service outlet. Where local regulations permit clamp may be used to prevent accidental removal of cable assembly from power-service outlet.
- 1.12 In multiple installations, electrical wiring may be run from booth to booth through knockouts provided in the sides of booth at ceiling level.
- 1.13 A 42A-type connecting block (Fig. 3) is included as part of the booth.
