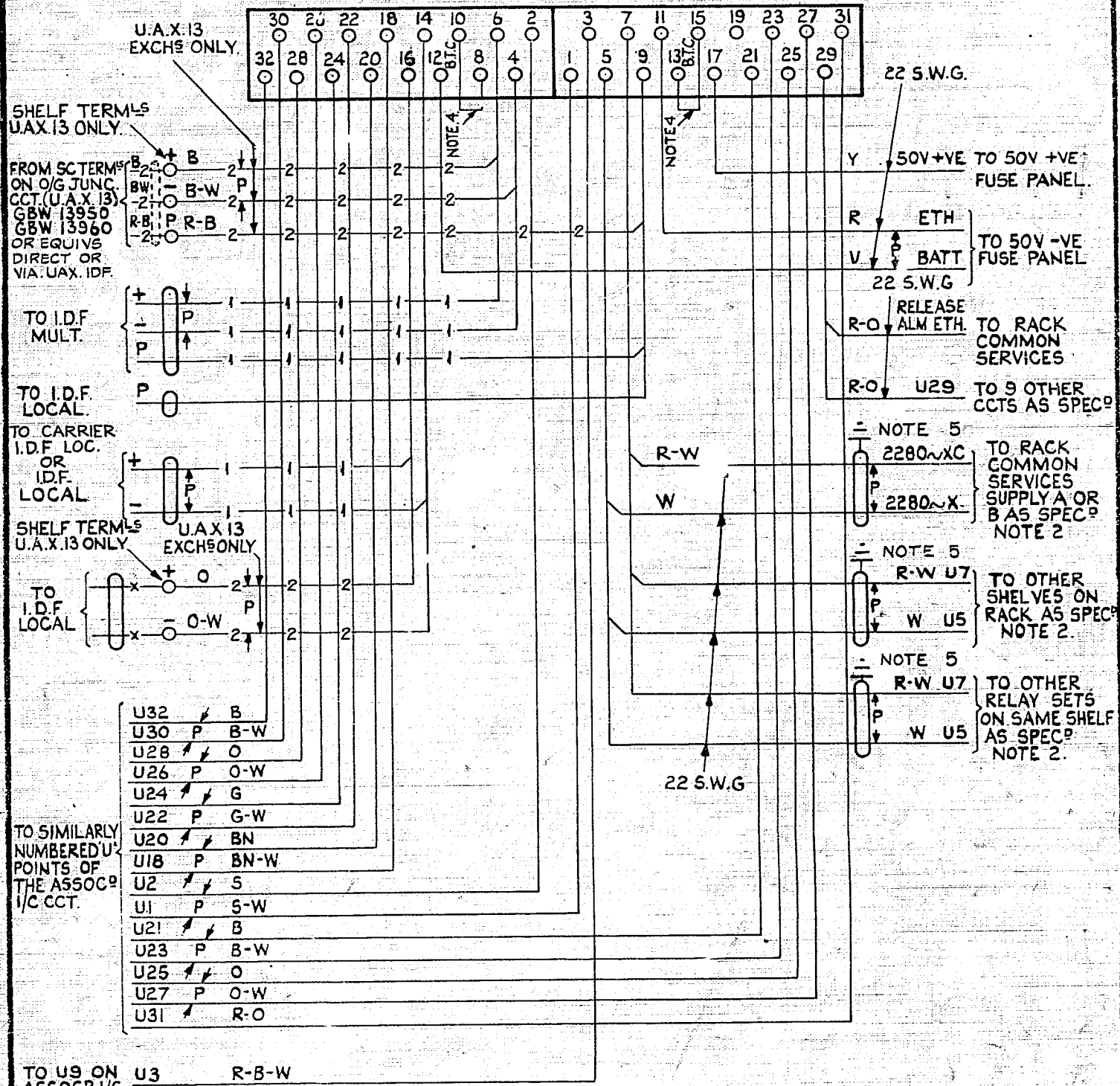


AS SEEN FROM REAR NOTE 1.
