BAI - Bridge Lifter Assignment Inquiry

COMMENTS

BAI operates in two basic modes. If "BL XXXX" is entered, the output will include the bridge lifter specified, its status (and mate's status, if mate exists), and frame location. If "LC X" is entered, the specified number of bridge lifters, their status, and frame locations are printed as above.

If the number of bridge lifters requested in the LC option is not satisfied, or no bridge lifters exist for that frame/zone, BAI prints the next best frame/zone.

CFA - Change Facility Attributes

COMMENTS

CFA input is an H-line with a single facility or range of facilities to be operated on. As many fields and prefixes as desired may be entered on the H-line, up to a maximum of 80 characters. As many H-lines as desired may be entered before exiting; input will be processed on a line-by-line basis. The only exception is the inquiry function which must be handled on a separate H-line.

Facility data fields may be changed by entering a prefix and data. Most fields may be blanked by entering the prefix and an exclamation mark (!). Facility data may be inquired on with a prefix and a question mark (?). Inquires may be used over a facility range. Range limits are one NNX, one cable, and one entity.

The following table shows CFA's various functions, the facilities for which these functions are legal and appropriate input formats.

COMMENTS

The information printed includes the service orders that 1) have been withdrawn (SO and WO), 2) have been completed by the MDF on the current date, 3) have not been completed by the MDF and have a current or past due date, 4) have been cancelled and have the current or a future due date, and 5) are in jeopardy at the close of the shift. Also printed are CTs that have been withdrawn or modified, or are unprinted (as OPN does).

CTP - Cable Transfer Frame Work Print

COMMENTS

CTP provides frame output and, optionally, work code tracking for a specified cable transfer order. Each time CTP is run the following is always printed: all printed and subsequently withdrawn or modified orders, all due date changes, and all remarks.

A. Printing

- If any cable pair transfer has been withdrawn from the order after the transfer has been printed at the frame, any CTP request for the order will automatically list all such withdrawn transfers.
- 2. CTP will provide frame output for an order on as many cable pair transfers within the order as desired. The user has several options to limit the number of cable pair transfers printed. Basically, the output can be limited to:
 - a) all pending transfers in the order
 - b) only the pairs never before printed

- c) only the withdrawn pairs that have been printed, or additionally, the first 1-99 pair transfers
- d) only the pairs pending in the order with the work code desired. Work codes may be: PBT, VBT, PCT, RCF, RBT, COM, US1, US2, US3, and US4.
- e) Only the transfers for indicated TO pairs or only the transfers for indicated FROM pairs.

If more than one of these options is specified, only transfers satisfying all specified conditions will be printed.

The work order number (WO) must be input on the H-line. If no other information is provided, all pending transfers in the order will be printed. In order to limit the output in accordance with options b) through e) above, the following can be specified:

- b) LS NEW: List the new additions.
- c) LC: Line count in the range 0 to 99. If LC 0 is specified only the withdrawn or modified transfers will be printed.

- d) PWC: Print work code. Any acceptable work code can be used (e.g., PBT, VBT, PCT, etc.).
- e) Either an I-line for the TO pairs or an 'O' line for FROM pairs (but not both) may be used. CP and CR may be entered on these lines.

B. Work Code Tracking

The user basically has three options for work code tracking:

- Print and set (change) work code simultaneously.
- 2) Set (change) work code independently of the old work code without receiving output; that is, set all pairs to a specified work code.
- 3) Change a specified work code without receiving output.

INPUT EXAMPLE

(an 0-line instead of I-line is optional)

CTS - Cable Transfer Summary

COMMENTS

Input is an H-line with the WO number, or ALL to list all transfer orders. To limit the number of transfers listed, enter the appropriate options. LS, LC, and ST are H-line inputs. Legal ST values are S, P, E, W, D, C, F, T, U, and M. If more than one option is specified, only those transfers satisfying all specified conditions will be printed.

Not appearing on the summary are pairs withdrawn whose withdrawal notices have already been printed at the frame, and pairs withdrawn before the transfer was printed at the frame. All remarks and due date changes are printed at the end of the summary.

B. For a List of All Transfer Orders

COMMENTS

To disconnect a particular DIP, enter only an O-line with the cable pair number or line equipment number.

To list or list and disconnect DIPs with particular characteristics, the following Hline input is required: line equipment type (TYP), entity (OE for non-SXS equipment or EN for SXS), number of DIPs to be processed (NUM), option (OP), and the most creation date that a DIP can have to be processed (DTE). DTE will refer to DIPs created before the date specified. Enter L to list DIPs; enter OP R to list and DIPs. For unrestricted disconnect processing, enter NUM ALL.

Optional H-line entries include equipment class of service (ECS), equipment features (EQF), frame location (LOC), and load factor (LF). This option allows only those OEs with the specified features to be listed or listed/disconnected. The LF option allows a single load factor (LF X) or a range of load factors (LF X/LF Y) to be specified. Load factors 1-10 are allowed. Any or all of the four equipment features may be requested on input (e.g., ???G,??NL,TSNL, etc.). LOC may be followed by one frame zone or a range of frame zones.

FOP - List Frame Orders Pending

COMMENTS

FOP has two basic modes: listing orders with pending reason codes and providing a summary report. The first mode can be limited by due date, frame due date, or range of dates; and/or specific pending codes. Up to four pending codes may be entered. If an order has no pending reason code but has secondary status "J", it will be counted as PR A1 by default.

An input of "OC OI" will print the eligible orders in SOI format rather than a tabular format. This cateogry is not valid for the "all orders" report or the summary report.

The summary report provides a count of orders by pending reason code, including a blank reason code.

COMMENTS

Orders may be requested by due date, a range of due dates, or an order number. Optionally, orders may be requested by OC (order category), SG (service segment) and REP (reprint). Any order that has been printed more than once will indicate on output that it is a reprint.

FTR - Frame Transfer Report

COMMENTS

This transaction is used to plan and manage the transfer of jumpers from one frame to another frame.

The I-line facility range must contain less than 10,000 working circuits. To report on more than 10,000 circuits, run FTR over several smaller ranges. If no frame is specified, the "to" frame is taken to be the COSMIC frame.

FWM - Frame Work Management

COMMENTS

Work Packages. Only packages not part of master work packages will be printed. Input is an H-line with one of the following: 1) a frame due date (or range of due dates) and a work location (1, 2, 3...8, or ALL), or 2) a work package number and a work location (1, 2, 3...8, or ALL). One to three work locations may be specified. The work location "ALL" entry is used to print one copy of the specified work package(s). One to three work package numbers may be specified. Optional H-line input is one to three work package types (WPT), and reprint (REP). The reprint option provides only that frame output which has already been printed.

NOTE: When FDD is input, only work packages will be printed. Master packages can only be printed with MPN input.

Master Work Packages. H-line input is up to three master package numbers and one work location number. The reprint option may be used.

Design Service. Input is a single FDD and work location "CPC" (or other locally-equivalent code). "REP" may be used.

Frame Orders. Input is the order number, or order number and circuit ID if only a single circuit from the order is desired. "OC OUT" is required if this order or circuit should also be deleted from a package.

Assignment Change Tickets. Input is a single frame due date and work location "ACT". "REP" may be used.

Maintenance Change Tickets. Input is a single FDD and work location "MCT".

Administrative Printout. Input is a FDD and work location "ADM". "REP" may be used.

The COUNT option can be used to obtain only a count of service orders. The segmentation (SG) option can be used to list orders to be completed by a particular service segment (R, S, B, C, etc.). SG ALL prints all pending orders with or without SG values. If SG option is not used, only orders with no SG value will be printed.

The output will include a work package number (WPN) if Frame Work Management is available to the user.

MPK - Modify Work Package

COMMENTS

Work Packages. One to three work package numbers (WPN) and order category (OC) are required input for all cases. Valid order categories are C (completion), S (summary), R (remarks), and U (unpackaging).

Master Work Packages. All options and capabilities described for work packages apply to master work packages. The only differences are that the input specifies one to three master package numbers (MPN) and individual orders may not be removed from packages. Only one work package or master package at a time may be unpackaged. Additionally, "OC SO" is available for master package summary reports.

Special Service Orders. Input is a FDD, work location CPC (or locally-equivalent code), and "OC S". Complete these orders individually with the completion option.

Remarks may be added to packages at any time with an H-line entry of "OC R" and an R-line. A maximum of 20 characters is allowed for a remark.

MVE - Move Jumpers to the COSMIC Frame or a Specified Conventional MDF

COMMENTS

Changes the working frame location from the present working frame to the specified frame if the circuit has cable pair and line equipment appearances on the specified frame. pairs will automatically be assigned between the line equipment and cable pairs. Tie pairs to another conventional frame are automatically assigned (if no special equipment appears in the circuit) between line equipment and concentrators, line equipment and trunk pairs, and circuits containing only one cable pair and one trunk pair. The transaction FTR (Frame Transfer Report) should be run before the MVE transaction to determine which circuits will require manual tie pair assignment.

The information printed includes 1) the phase alert status and message regarding trough congestion for the COSMIC or ESS frame: an entity summary report specifying entity loading parameters and DIP parameters; 2) the list of orders (and related orders) by order type due for completion at the frame on the present day (orders which have already received a frame completion will be noted); same information for orders due on the next two days; and audit section including orders overdue at the frame, cancelled orders due today, orders which have received installer's (PAO) completion but not a frame completion, and orders with pending reason codes; 3) a summary of cable throw work, including withdrawn, modified, and unprinted work; and 4) reassociation orders and work orders overdue, due today, due tomorrow due the day after.

INPUT EXAMPLES

COMMENTS

Required input consists of 1) a frame due date or range of frame due dates, and 2) an order category option (A, S, AM, SU, SP, or NP). When the "A" order category is used, three additional options are available. WPT (work package type) and PT (package time) are entered to assemble packages by type and time. When the PT is used alone, a work location number (WL X) is also required. The package time entry overrides the standard time and works only for that particular PAK execution. When these options are used, all the assembled orders will require work at the specified WL.

The various types of input are described below.

- 1. Assemble work packages. Only a single frame due date is used. Optional input is WPT, PT, and WL. "OC A" assembles frame output into work packages.
- 2. Assemble packages for a range of dates.
 "OC AR" will assemble packages according to the input specifications for all dates up to and including the FDD.
 Input options for "OC A" are legal for "OC AR".
- 3. Assemble a multicircuit order. Input is the order number and "OC A".

- 4. Assemble a master work package. Input is a single frame due date, work package type, work location number, and "OC AM". One, two, three, or all work package types may be considered for a master package with prefix WPT and type codes or "ALL". Optionally, the master work package size can be limited with the package time (PT) entry.
- 5. Summarize packaged and unpackaged work.
 Input is a FDD or range of FDDs, and "OC S". The summary option can be used repeatedly.
- 6. Summarize unassembled frame work. Input is a FDD or range of FDDs and "OC SU".
- 7. Summarize packaged frame work. Input is a FDD or range of FDDs and "OC SP".
- 8. Identify unprinted work packages. Input is a FDD or range of FDDs and "OC NP".

RFO - Remove Frame Order

COMMENTS

An optional frame due date or range of frame due dates can be entered. If a single FDD is entered, RFO will remove all frame orders that have been printed or withdrawn up to and including the date entered. If a range of FDDs is entered, RFO will remove all frame orders that have been printed or withdrawn whose FDD falls within the range. If frame work management is implemented, all work packages and master work packages that have been completed will also be released according to the input.

CAUTION: The use of SCF is not recommended as a normal procedure. Use of SCF will make the WSL (work status list) report and other frame management reports useless. Its misuse can cause data base inaccuracies.

COMMENTS

Order numbers entered must refer to the latest version (either an original, modification, or cancellation) of the SO. A circuit ID identifies the order. Valid circuit identifiers are: TN, XN, PL, CP, OE, and inventoried TK.

SCM can be used to manually force the creation of a DIP by entering an O-line with STO LI. The CP must be specified if there is more than one CP in the circuit.

NOTE: If the wire center is using Frame Work Management procedures, do not use SCM; use MPK instead.

Printout includes Frame Work Management data, MDF work required, MDF completion, PAO completion, and an indication of frame output.

SOT is used to designate the TTY terminal number(s) which will receive notification that immediate frame output should be requested. If the RÉCORD is in use, have the Data Base Manager move contents of FO RECORD 1 and six pointers.

The groups are: Control Group for ESS, Marker Group for 1XB and 5XB, (OE designates each of these groups) and Entity for SXS (EN designates group for SXS). The following parameters can be changed: CLF, RLF, FR, DIP, ECS, and JL.

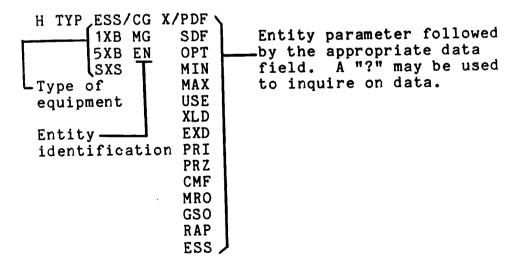
