When a direct-line, flat-rate contract has been in force for one year, service at a residence may be suspended for a period not exceeding four months in one year, and a rebate allowed equivalent to half the rate during the period of suspension. On a four months' suspension, this rebate would amount to \$8.00, reducing the net cost of direct-line, flat-rate service to \$40.00 per annum.
